



Information on the Personal Data Controller

In accordance with Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: GDPR), we inform you that:

1. The Controller of your personal data is Expo Mazury S.A., ul. Grunwaldzka 55, 14-100 Ostróda (hereinafter: the Controller).
2. You can contact the Controller at the email address: sekretariat@expomazury.pl, phone: 89 506 58 00 or in writing at the Controller's registered office.
3. The legal basis and purpose for processing your personal data by the Controller is:
 - a. in case consent is obtained for receiving marketing communications, including trade information - point (a) of Article 6(1) of GDPR, i.e. the processing of your data takes place on the basis of your consent given to send you electronic communications (emails) concerning marketing content, including trade information on Expo Mazury S.A. and its services or events (among others, the Newsletter).
 - b. point (f) of Article 6(1) of GDPR, i.e. the processing takes place due to our legitimate interest consisting in providing an answer to a question, information on our activities, and the products or services we offer, if requested by interested parties.
4. Provision of your personal data is voluntary, however, lack of consent results in the impossibility to provide a response.
5. Your personal data will only be processed for as long as necessary to accomplish the above-mentioned purposes and settle your matter and if consent is granted to receiving marketing content, including trade information, until it is revoked.
6. Your personal data may be shared with our trade partners, especially providers of IT solutions, entities that offer us accounting, legal, delivery or post services, exclusively in relation to the fulfilment of our aims.

7. You are entitled to demand access to your personal data as well as to correct and remove them or limit the processing of your data. You are also entitled to transfer your personal data. Furthermore, you are entitled to object to the processing of your data - if data processing is based on point (e) or (f) of Article 6(1) of GDPR. If personal data are processed for direct marketing purposes, the data subject has the right to object at any time to processing of personal data concerning him or her for such marketing, which includes profiling to the extent that it is related to such direct marketing.
8. If your personal data are processed based on your consent to the processing of personal data, you have the right to withdraw such consent any time. Withdrawal of the consent does not affect the legitimacy of processing that took place based on the consent granted prior to the withdrawal. Withdrawal of the consent may take place through informing us via email provided in section 2 above or in writing at the address of the Controller.
9. Your data will not be used for automated decision-making, including profiling, as described in Article 22(1) and (4) of GDPR.
10. If you believe that the processing of your personal data by Expo Mazury S.A. infringes provisions of GDPR, you are entitled to lodge a complaint with the supervisory authority responsible for the protection of personal data in the Member State that you usually reside in, work in or where the alleged breach has taken place.
