



Information on the Personal Data Controller

In accordance with Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: GDPR), we inform you that:

1. The Controller of your personal data is Expo Mazury S.A., ul. Grunwaldzka 55, 14-100 Ostróda (hereinafter: the Controller).
2. You can contact the Controller at the email address: sekretariat@expomazury.pl, phone: 89 506 58 00 or in writing at the Controller's registered office.
3. The legal base and purpose of processing your personal data by the Controller is point (a) of Article 6(1) of GDPR, i.e. the processing of your data takes place on the basis of your consent given to send you electronic communications (emails) concerning marketing content, including trade information on Expo Mazury S.A. and its services or events (the Newsletter).
4. Provision of the data is voluntary, however, lack of consent results in the impossibility of receiving the Newsletter.
5. Your personal data will be processed until you revoke your consent (i.e. resign from the Newsletter).
6. If we use the services of external subcontractors to send you the Newsletter, we oblige them to follow Article 28 of GDPR. Other type of transfer of personal data to third parties is excluded.
7. You are entitled to demand access to your personal data as well as to correct and remove them or limit the processing of your data. You are also entitled to transfer your personal data. Furthermore, you are entitled to object to the processing of your data - if data processing is based on point (e) or (f) of Article 6(1) of GDPR. If personal data are processed for direct marketing purposes, the data subject has the right to object at any time to processing of personal data concerning him or her for such marketing, which includes profiling to the extent that it is related to such direct marketing.

8. If your personal data are processed based on your consent to the processing of personal data, you have the right to withdraw such consent any time. Withdrawal of the consent does not affect the legitimacy of processing that took place based on the consent granted prior to the withdrawal. Withdrawal of the consent may take place through informing us via email provided in section 2 above or in writing at the address of the Controller.
9. Your data will not be used for automated decision-making, including profiling, as described in Article 22(1) and (4) of GDPR.
10. If you believe that the processing of your personal data by Expo Mazury S.A. infringes the provisions of GDPR, you are entitled to lodge a complaint with the supervisory authority responsible for the protection of personal data in the Member State that you usually reside in, work in or where the alleged breach has taken place.
